# New Online Mapping Tool – New Hampshire Coastal Viewer

NHDES, in collaboration with the University of New Hampshire's GRANIT System and other project partners, have launched the <u>New Hampshire Coastal Viewer</u> an online mapping tool that gives anyone with an Internet connection the ability to access more than 150 spatial data sets and to make and share their own customized maps. # NHDES Dam numbers have changed

Dam owners will be noticing a change in your dam number in future correspondence. As development has expanded over the years, the number of dams in certain towns has grown significantly. Some towns are nearing 100 dams, and our historic numbering system was not compatible with that. In addition, the old system made it difficult for some computer applications to manipulate and sort the data. Example: Old dam# 014.08, New dam# D014008. # **Used Oil Gift Grant**

The Department of Environmental Services issues grants for the purpose of establishing and improving used oil collection centers serving Do-It-Yourselfers who change their own automotive oil. Grant funds, up to \$2,500 per year, can be used to assist with the purchase of used oil management equipment. Municipalities and motor vehicle inspection stations are eligible to apply for yearly grants related to the collection of Do-It-Yourselfer used oil and/or automotive oil filters. Grants are awarded on a first-come first-serve basis with priority given to first time applicants or applicants in underserved areas. The NH Department of Administrative Services has recently contracted with Complete Recycling Solutions to provide recycling services for fluorescent lamps, ballasts, dry cell batteries and mercury devices. This is a change in vendor, and municipal officials should contact the new vendor to take advantage of the state-negotiated pricing structure.
